#### 2.0 OPENING REMARK

The meeting commenced by 10:30am with the Chairman's opening remarks and thereafter followed by individual opening prayer.

The agenda of the meeting were presented as follows:

### 4.0 Reading, Correction and Adoption of the Minutes of Inaugural and 1st Regular Meeting

The phrase "......and no upfront payment for execution of activities by World bank" in line 4 of item 4.0 was corrected to read "...and not by upfront payment for execution of activities by World Bank.".

In line 5 of item 4.0, page 2, the word "....the..." was inserted in between the words "in execution". The phrase was corrected to read "....in the execution....".

Line 6 of item 4.0, paragraph 1 previously reported as "....programmes becomes necessary to ensure..." was corrected to read "....programmes. It became necessary to ensure that..."

A text in paragraph 1, line 7 written as "...carried accordingly..." was corrected to read "....carried out accordingly..."

The word "....therefore.." was removed from Line 1, paragraph II of item 4.0. ".....he added that the AC was therefore constituted ...." It was rephrased to read ".... he added that the AC was constituted ...."

The phrase ".... delay in the of releases..." reported in item 4.0, paragraph 4, Line three (3) was corrected to read ".... delay in the release of funds..."

The words ".... that there is...." was inserted in Line 5 of paraph five, item 4.0 to read ".....this is to ensure that there is no over budgetary expenditures".

The word "to" duplicated in line 1, paragraph 6 was removed. The phrase previously reported as "....one of the primary purposes of the AC to is to..." was corrected to read "....one of the primary purposes of the AC is to..."

In line 3 of Paragraph five, page three (3), the word "Centre" was pluralized to Centres" and "...the.." was added to "the internal Control System".

In paragraph six, page 3, the number "...seventeen..." written in words was requested to also be written in figure "(17)".

In Paragraph 2, line 7, of page 4, the word "...be..." was added to the phrase "...it was agreed that these documents should be ....".

The term "...Committee...." omitted in the last line of the last paragraph was corrected to read "...The Committee agreed to ...."

After correction, Prof. Adie moved for adoption of the minutes and seconded by Maiyaki Hamisu Musa.

#### 5.0 MATTERS ARISING

The Committee Chairman presented the following documents for the Committee's consideration and adoption before they were sent to the ACE leaders.

### i. Notification of Appointment and commencement of assignment

The draft letter of notification of commencement of the Committee's activities and its terms of reference (ToRs) was presented and the Committee members after studying the draft agreed that since the Committee's assignment covers the two ACEs, all the letters should be addressed to each Centre leader separately, except the letter for submission of budget estimate for AC activities which should be addressed to Centre Leader, ACENTDFB only and copied to the Centre leader, ACENPEE.

#### ii. Request for working documents

The draft letter requesting for the following documents from the ACE leaders was read:

- a. Project Implementation Plan (PIP)
- b. Annual Work Plan
- c. External Audit Report
- d. Internal Audit Report
- e. Accountant's Financial Report (January 2022 to date)
- f. Statement of income and expenditure from January 2022 to date

Similarly, the Committee agreed that the letter should be addressed to the two Centre leaders as individual entities.

### iii. Letter of Submission of Proposed Budget Estimate for the Activities of the Audit Committee for July 2022 to June, 2023.

The draft Budget was studied by the Committee and the following corrections were made on the budget items:

- a. **Laptops**: The number of required laptops was scaled down to two (2) Units for the Committee Chairman and Secretary. This is to assist in effective and efficient secretariat services and report writing.
- b. **Refreshment**: The provision for refreshment (tea break and lunch) was reviewed from five (5) to six (6) persons consisting of five (5) Committee members and one (1) Secretariat Assistant.
- c. **Recharge card/data.** Provision for recharge card for Committee members was reviewed upward from four (4) to five (5) members.
- d. **Capacity Building**: The Committee added capacity building for members of the Committee. It was estimated at Two Million, Five Hundred Thousand Naira Only (¥2,500,000).
- e. The corrected total Budget stood at Five Million, Three Hundred and Forty-Four Thousand Naira (\$\frac{\mathbb{N}}{45}\$,344,000) Only; as against the previous figure of Three Million, Three Hundred and Sixty-Nine Thousand Naira (\$\frac{\mathbb{N}}{43}\$,369,000) Only.

- 6. institutional arrangements and processes for risk management across the ACEs.

Finally, the AC hereby solicits for the support of the ACEs in carrying out its assignment on behalf of the World Bank Group and the ABU Governing Council. Thank you.
