- 34. The Committee observed the lack of full utilization of the project Accounting Software. This was attributed to a lack of participation in training and retraining of account/audit personnel. The Committee agreed to represent the need for retraining of the Centre Staff to enhance their knowledge of the Package and domesticate the software.
- 35. The phrase " ... a competent Store Officer has been appointed.." in line 38 was replaced with "The Committee noted that a new store officer has been appointed as" and the phrase "..the Centre outgone store officer after his voluntary retirement..." was corrected to read "..the former Store officer who had voluntarily retired from active service".
- 36. Line 39 previously written as "Significant progress from 30% to 60% has been achieved in the submission of retirement for unretired advances." was corrected to read "The Internal Auditor assured the Committee that a significant progress (from 30% to 60%) has been achieved in the retirement of cash advances."

37. Similarly. The phrase "... advise the Audit Department to ensure a minimal percentage of unretired cash advance is achieved." in line 39 was corrected to read "...advised the Audit Department to ensure a minimal percentage of unretired cash advance".

38. Review of the report of progress made by the Nigerian Centres under ACE Impact as of October, 2023.

The Committee reviewed the report of the progress made by ACENTDFB and applaud the Centre for attaining a 100% level of achievement in DLIs i.e DLI 3.3,4.2,7.1,7.5; completion of the administrative building; development of a Regional Strategy Plan, Academic brief and draft research policy; completion of PASET benchmark and improvement in the number of external research grants won. The Committee however advised the Centre to improve its achievements in other activities to increase its percentage performance in non-performing DLIs.

The Committee also advised the Centre to collaborate with other high-performing ACEs and Universities in areas of research.

39. The Committee appreciated the comprehensiveness of the report on the DLIs and their percentage attainments. However, the Committee advised that all DLIs should be arranged serially (DLI1.0.....to the last) with their percentage attainments, challenges and improvement measures taken.

40. Review of ACE Impact DLR 4.3 Verification Checklist/Committee Report for ACENTDFB

41. The Committee noted the Centre's achievement in the construction of a Crime Scene Demonstration Lab, Moot Court and Administrative Building and commended the Centre for the performance. The Committee reviewed the verification checklist and agreed to confirm from the M&E officer if the Physical inspection of the new Admin building and its components facilities have been done by the relevant authorities.
