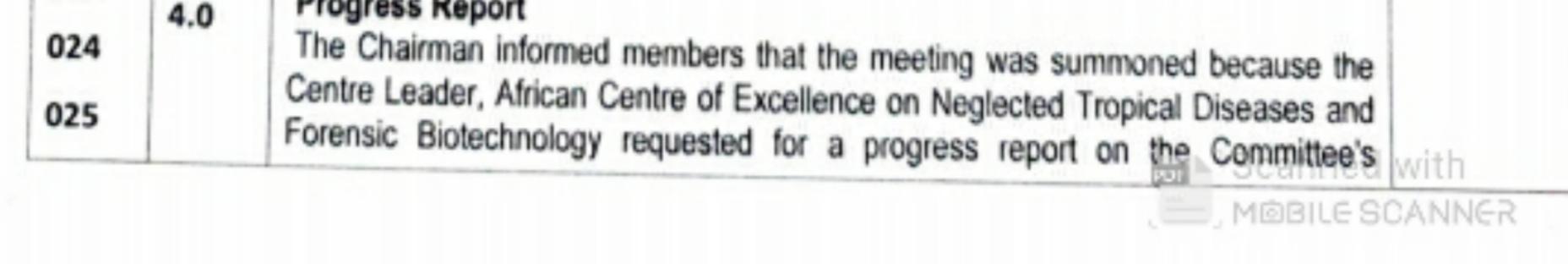

033	5.0	Background of the Assignment
034		The Chairman informed members that the DLI 7.5 is an Institutional Impact
035		milestone of the Africa Centre of Excellence (ACE) for development and part of the
036		activities to be carried out was to look into how to strengthen or increase revenue for the University as well as commercialization of research products. Furthermore
037		the tasks would include how Internally Generated Revenue (IGR) can be belief
038		harnessed and cultivated, and also to see how research products can improve the Internally Generated Revenue. The timeline for the assignment is 15 <sup>th</sup> December,
039		2023 but the Committee should agree to conclude the work much earlier. Once
040		the task is accomplished, the University will earn \$100,000.00.
041		The Chairman stressed that the Committee should articulate a proper budget for expenses expected throughout the course of the assignment which would be
042		forwarded to the Vice-Chancellor for approval and the funding will come from one
043		of the Centres of Excellence that have concluded their DLI.
044	6.0	COMMENTS
045		A member expressed concern over the length of time expected for the completion
046		of the assignment. He suggested taking the next 3 months to deal with it.
047		The Chairman informed members that documents on the DLI 7.5 would be
048		forwarded to them. It was proposed that the meeting reconvene on Friday 20th January, 2023 when members must have read and understood what the
049		assignment is about.
050		Another member offered to share some documents on Internally Generated
051		Revenue with members informing that he was privileged to work on a Committee
052		on Internally Generated Revenue for the University in 2010 and 2012. He further emphasized the need to utilize Alumni in the area of Internally Generated
053		Revenue.
054		Another member suggested that the committee should make a holistic action plan rather than quarterly plan then evaluate the present research culture and find ways
055		to develop strategies to move from gestation to maturation level.
